

# Vodafone Business Caps, Infinite Business Single and Shared Plans, Infinite Business Combo Plans and Bundled Mobile Broadband Plans

## What Terms and Conditions Apply to my Vodafone Infinite Single or Shared Business Plan, Vodafone Business Cap Contract, Infinite Business Combo Plan or Bundled Mobile Broadband Products?

- (a) This document sets out terms and conditions that apply to specific Vodafone contracts and products (collectively, the “**Products**”).
- (b) The terms and conditions that will apply to your Product or Products are:
  - (i) all the terms and conditions provided to you when you agree to purchase a Product, including the terms and conditions contained in this document and any terms and conditions contained in any application form you complete when purchasing a Product; and
  - (ii) all the terms and conditions contained in the Vodafone Standard Form of Agreement (**SFOA**), which is available at [vodafone.com.au](http://vodafone.com.au),  
(collectively, the “**Terms**”).
- (c) When you agree to purchase a Product, you accept the Terms. Your contract with Vodafone commences on your acceptance of the Terms.
- (d) Some Products have a minimum contract term. If your contract is terminated before the end of this term, you may be required to pay fees, such as an Early Exit Fee or a Handset Recovery Fee. Depending on the Product this may be in addition to any applicable handset payments and additional or excluded call, data or service costs. Early Exit Fees are set out in the pricing table for your Product.
- (e) Activation of your Product may occur after your contract has commenced. Any minimum contract term that applies commences when your Product is activated.
- (f) You may suspend your contract for between 1 and 3 consecutive calendar months once during the minimum contract term. You will be charged a fee for each month if your contract is suspended. Your minimum contract term will be extended by the period of any suspension.
- (g) The Terms may be changed by Vodafone from time to time. Vodafone will comply with relevant laws, regulations and industry codes if it makes any such changes.

## Important Things You Need to Know

### Availability

- (a) The Products are for small to medium business use only, and are not available to large business/corporate and commercial customers. Large business/corporate and commercial customers should contact Vodafone for information about Vodafone's corporate business products.
- (b) The Products are available to credit approved customers only.
- (c) Unless otherwise stated, up to 3 Vodafone Business Cap Products, together with a maximum of one Vodafone Bundled Mobile Broadband Product, can be used per connection to the Vodafone network.
- (d) Devices may be locked to the Vodafone network. A fee may apply to unlock.
- (e) Vodafone's Fair Use policy applies to all Vodafone Products.
- (f) To activate international roaming, contact Vodafone at least 72 hours before you leave Australia. Vodafone may require you to pay a security deposit before activating international roaming. Some Vodafone services may not be available outside Australia.

### Factors affecting availability and performance

- (a) Network coverage and many other factors may affect the availability and performance of certain Products.
- (b) Certain Products, services and functions are only available if used in conjunction with a compatible mobile or other device and if in a compatible coverage area. Not all devices are compatible with Vodafone networks.
- (c) All Vodafone services are subject to device capabilities and network limitations and availability. A compatible 3G device is required to access 3G services. If you have a *handset* which is U2100MHz or U2100/850MHz compatible but not U900MHz compatible you will experience 3G coverage in metro areas (3G Mobile Broadband Standard Coverage area and, if available for your handset, the 850 Mobile Broadband Coverage area) and 2G (2.5G GPRS or 2.75G Edge) in all other coverage areas. If you have a *modem* which is U2100MHz or U2100/850MHz compatible but not U900MHz compatible you will experience 3G coverage in metro areas (Vodafone 3G Mobile Broadband Standard Coverage area and, if available for your modem, the Vodafone 850 Mobile Broadband Coverage area) but no coverage at all in other areas of Australia (i.e. no coverage in Vodafone's 3G Mobile Broadband Regional Coverage area).  
Broadband speeds and high bandwidth applications, such as video streaming, video calling, Mobile TV and full track downloads, are only available in Vodafone's 3G Mobile Broadband Standard Coverage area; and, if you have a U850MHz compatible device, in Vodafone's 850 Mobile Broadband Coverage area; and, if you have a U900Mhz compatible device, Vodafone's 3G Mobile Broadband Regional Coverage area (however speeds in Vodafone's 3G Mobile Broadband Regional Coverage area will be slower than when in Vodafone's 3G Mobile Broadband Standard Coverage area or, if available for your device, Vodafone's 850 Mobile Broadband Coverage area). You agree to refer to [www.vodafone.com.au/coverage](http://www.vodafone.com.au/coverage) for coverage details

and [vodafone.com.au/devicefrequency](http://vodafone.com.au/devicefrequency) for details of devices and their frequencies before purchase, so that you can confirm that for your intended use of the services, your address/es are located in the appropriate Vodafone coverage areas and that the device you wish to select is compatible with the Vodafone coverage area where your address/es are located.

- (d) Notwithstanding anything else in Vodafone's contract with you, Vodafone may provide services to you using any telecommunications network Vodafone considers appropriate, including (but not limited to) the "Vodafone" networks operated by, for or on behalf of Vodafone Network Pty Limited and Vodafone Australia Pty Limited and the "3" network operated by, for or on behalf of Vodafone Hutchison Australia Pty Limited. For more information about these networks, see the coverage maps available at [www.vodafone.com.au/coverage](http://www.vodafone.com.au/coverage) and [www.three.com.au/coverage](http://www.three.com.au/coverage).

### **Data services**

- (a) For Products that provide data access capabilities, a data session starts when you first connect to data services and ends when you disconnect from data services.
- (b) When using data services, some internet services, including web sites and email, may not be accessible.
- (c) Subject to your rights under the *Competition and Consumer Act 2010* or other relevant legislation (including the *Australian Consumer Law*), Vodafone does not make any warranty regarding any software or data provided or available to you in connection with data services, including with respect to how that software or data operates on your device or interacts with applications.
- (d) Unless otherwise stated, data usage is measured as the combination of both data you send (upload) and receive (download).

### **Data service access devices**

- (a) It is your responsibility to confirm that data service access hardware (including any modem or Pocket WiFi™2 device) is compatible with each PC, laptop or other computing device that you will use your Product with (if appropriate).
- (b) Non-Vodafone supplied modems or tablet devices can only work on our network if they are compatible, unlocked, and have not been reported as lost or stolen devices.
- (c) Vodafone is not required to provide you with technical support if you use non-Vodafone supplied data access hardware (such as your own USB modem or tablet device), although Vodafone may do so at its discretion.
- (d) The Pocket WiFi™2 device can operate with a maximum of 5 WiFi enabled devices at any one time.

### **Rates and charges**

- (a) Details of the rates and charges, including any minimum spends which apply to the Products are contained in the Terms. The minimum total cost over contract term is calculated by multiplying the minimum monthly spend by the contract term.
- (b) Vodafone Business Cap, Vodafone Infinite Business Single or Shared Plan and Vodafone Infinite Business Combo Plan Products feature "**included**

**value**". Included value can be used to pay for many (but not all) services available from Vodafone. Included value is credited to you for payment of your minimum monthly spend.

- (c) The Vodafone Bundled Mobile Broadband Products offer "included data". Included data can be used to upload and download data to or from the internet via a compatible Mobile Broadband device. Included Value is credited to you for payment of your minimum monthly spend.
- (d) If your usage of a Product exceeds your included value and/or your included data (as appropriate), or you use a service that is not payable from your included value or included data (as appropriate), you will be charged an amount additional to your minimum monthly spend.
- (e) Unless otherwise stated, if you do not use all your included value and/or your included data (as appropriate) in the relevant month, that included value and/or included data (as appropriate) is forfeited, is not refundable, and will not carry over into any other month.
- (f) Unless otherwise stated, the section of the Terms titled "Vodafone Rates: What is payable from my Vodafone Business Cap, Vodafone Infinite Business Single or Shared Plan or Vodafone Infinite Business Combo Plan Product's included value?" specifies which services are or are not available to be paid from your included value and the rate at which additional services will be charged.
- (g) For Vodafone Bundled Mobile Broadband Products, all non-data use (eg voice calls, SMS/MMS and content) is charged in addition to your Minimum Monthly Spend. Refer to the Section titled – "[Rates and Charges for Non-Data Use on Bundled Mobile Broadband Products](#)" for the rate at which these services will be charged.
- (h) Each call charge is rounded up to the nearest cent before GST is included.
- (i) Unless otherwise stated, rates specified for services are GST inclusive.
- (j) Unless otherwise stated, call usage is billed in blocks of 30 seconds for Vodafone Infinite Business Single and Shared Plan Products, Infinite Business Combo Plan Products and 60 seconds for Vodafone Business Cap Products. Usage is rounded up to the end of the current block.
- (k) All rates and charges are subject to change. Vodafone will comply with relevant regulations and industry codes with respect to such changes.

## **Billing**

- (a) In your first bill, you will be charged your minimum monthly spend for the following month. Your first bill may also include a prorated amount from the date you connected to your first bill.
- (b) You may choose to purchase additional Products from time to time. Charges for these Products will be applied to your bill.
- (c) Paperless billing is the default bill delivery method for Vodafone customers. Vodafone will provide paper bills without charge to disabled or disadvantaged customers. Otherwise, Vodafone will not provide paper bills except in special circumstances, in which case, at its discretion, Vodafone may charge \$2.20 per paper bill.

- (a) You will receive a data allowance or Unlimited BlackBerry® Email (BlackBerry® Internet Service (BIS version) allowance (not available unless purchased separately with \$29 Business Cap Contract Products, \$20 SIM

Only Business Cap Products, \$45 Vodafone Infinite Business Single Plan Products or any Vodafone Infinite Business Shared Plan Products)).

- (b) If you have chosen to include Unlimited BlackBerry® email with your Vodafone Infinite Business Single Plan Product, Vodafone Infinite Business Combo Plan Product or Vodafone Business Cap Product, sections (d) – (i) under the heading “Unlimited BlackBerry® Email and Internet Browsing Packs Products” below also apply to you.
- (c) If you have chosen to include a Vodafone Bundled Mobile Broadband Product with your Vodafone Infinite Product or Vodafone Cap Product, the entire section titled “Vodafone Bundled Mobile Broadband Products” below also applies to you.
- (d) Any data allowance which is part of your included value is only available for use via your compatible handset. It is not available for use on a mobile broadband device.
- (e) You may change from one Vodafone Infinite Business Single Plan Product, Vodafone Infinite Business Shared Plan Product, Vodafone Infinite Business Combo Plan Product or Vodafone Business Cap Product to another Vodafone Infinite Business Single Plan Product, Vodafone Infinite Business Shared Plan Product, Vodafone Infinite Business Combo Plan Product or Vodafone Business Cap Product once per monthly billing period by calling Vodafone Customer Care, and agreeing to the terms and conditions of the new Vodafone Infinite Business Single Plan Product, Vodafone Infinite Business Shared Plan Product, Vodafone Infinite Business Combo Plan Product or Vodafone Business Cap Product. Any credit or other benefits from your existing Product will be forfeited, unless otherwise advised. If you are changing to a less expensive Vodafone Infinite Business Single Plan Product, Vodafone Infinite Business Shared Plan Product, Vodafone Infinite Business Combo Plan Product or Vodafone Business Cap Product or to a month to month Product or to a prepay Product, fees, including a Plan Change Fee may apply. Any Product change will take effect from the start of your next monthly billing period. Contact Vodafone Customer Care for more information.
- (f) Standard rates apply once your monthly data allowance has been exhausted. Additional data charges cannot be paid from your Vodafone Infinite Business Single Plan Product's, Vodafone Infinite Business Shared Plan Product's, Vodafone Infinite Business Combo Plan Product's or Vodafone Cap Product's included value.
- (g) Your data allowance can only be used in Australia, on Vodafone networks.

The following term (h) only applies to you if you purchase a 12 or 24 month Vodafone Infinite Business Single Plan Product, Vodafone Infinite Business Shared Plan Product, 24 month Vodafone Infinite Business Combo Plan Product or 12 or 24 month Vodafone Business Cap Contract Product (this term does not apply to any Vodafone Month to Month Infinite Business Single Plan Product or any SIM Only Business Cap Product):

- (h) Any \$0 upfront or discounted mobile device offers are only available from Vodafone's selected mobile device range at the time that you agree to a contract and cannot be redeemed for cash or as a credit against your service costs with Vodafone. These mobile device offers are not available if you switch between contracts during the minimum contract term.

The following terms and conditions (i) – (k) only apply to you if you purchase a Vodafone Month to Month Infinite Plan Product or a SIM Only Cap Product (these terms and conditions do not apply to any 12 or 24 month Vodafone Infinite Single or Shared Business Plan Products or 12 or 24 month Vodafone Business Cap Contract Products):

- (i) Charges for your Month to Month Infinite Business Single Plan Product or SIM Only Business Cap Product are in addition to any handset repayments (if applicable).
- (j) The Minimum Monthly Spend is payable for each full monthly billing cycle in advance.
- (k) If you add or remove the Month to Month Infinite Business Single Plan Product or SIM Only Business Cap Product mid billing cycle, the Minimum Monthly spend will be pro-rated.

The following terms and conditions (l) – (r) only apply to you if you purchase a Vodafone Infinite Business Shared Plan Product (these terms and conditions do not apply to any 12 or 24 month Vodafone Infinite Single Business Plan Products, 12 or 24 month Vodafone Business Cap Contract Products, Vodafone Month to Month Infinite Plan Products or SIM Only Cap Products):

- (l) You may allow any person to have a connection to your Vodafone Infinite Business Shared Plan Product. If you do so, you will be responsible for paying any usage fees and any other charges which are incurred by a person connected to your Vodafone Infinite Business Shared Plan Product (including, but not limited to, excess usage charges and charges for excluded services such as content purchases).
- (m) Your Vodafone Infinite Business Shared Plan Product's included value will be used by each connection to your Vodafone Infinite Business Shared Plan Product on a first-in-first-served basis.
- (n) You may change the number of connections to your Vodafone Infinite Business Shared Plan Product during the minimum contract term, provided you never have less than two connections. The Early Exit Fee will be payable if less than two connections to your Vodafone Infinite Business Shared Plan Product are maintained during the minimum contract term.
- (o) You may add connections in excess of the specified "Maximum Connections included for Minimum Monthly Spend" for your Vodafone Infinite Business Shared Plan Product, by paying the specified additional connection fee. However, doing so will not increase your Product's included value or included data. You may upgrade to a higher value Vodafone Infinite Business Shared Plan Product at any time. Contact Vodafone Customer Care for more information.
- (p) If your Vodafone Infinite Business Shared Plan Product monthly data allowance is exhausted, any amounts payable for additional data usage will be shown on your bill separately for each connection.
- (q) Your mobile phone may be used as a tethered modem with your Vodafone Infinite Business Shared Plan Product. Data used by a tethered mobile phone will be deducted from your included monthly data allowance.



- (r) You will be issued a Primary Account PIN. You must keep this Primary Account PIN confidential and must not disclose the Primary Account PIN to any other person, including those who are entitled to be connected to your Vodafone Infinite Business Shared Plan Product. Doing so will compromise privacy across the entire range of connections to your account (for example, the call records / usage information of each connection to you Vodafone Infinite Business Shared Plan Product may become visible and accessible by all other users in the group if the Primary Account PIN is shared). Disclosure of your Primary Account PIN may also compromise the security of sensitive information such as credit card details, and will allow those with access to the PIN to, amongst other things, add or change services connected to your account and/or purchase additional hardware.

The following terms and conditions (s) – (x) only apply to you if you purchase a Vodafone Infinite Business Combo Product (these terms and conditions do not apply to any 12 or 24 month Vodafone Infinite Business Single Products, 12 or 24 month Vodafone Infinite Business Shared Products or 12 or 24 Month Vodafone Business Cap Products):

- (s) The Minimum Monthly Spend is payable for each full monthly billing cycle in advance and is non-refundable. All other charges are billed at the end of the monthly billing cycle in arrears.
- (t) You will be issued with two SIM Cards – a Handset SIM Card and a Mobile Broadband SIM Card. The Handset SIM Card is for use in the handset provisioned with your Vodafone Combo Cap or Vodafone Infinite Combo Product and the Mobile Broadband SIM Card is for use in the USB Modem or Pocket WiFi™2 device provisioned with your Vodafone Combo Cap or Vodafone Infinite Combo Product.
- (u) You will be allocated a Monthly Included Handset Value which will vary depending on which Combo Cap or Vodafone Infinite Combo Plan Product you purchase. Your Included Handset Value is only available for use via your Handset SIM Card and is not available for use via your Mobile Broadband SIM Card.
- (v) **Usage of services via your Handset SIM Card (not Mobile Broadband SIM Card):** Unless otherwise stated, the section below titled “Payable from included value” specifies which Products are available to be used from your Included Handset Value via your Handset SIM Card and the rate at which additional services will be charged, and the section below titled "Not payable from included value" specifies products which cannot be used from your Included Handset Value via your Handset SIM Card and the additional rate at which you will be charged, if you use those services via your Handset SIM Card.
- (w) **Usage of services via your Mobile Broadband SIM Card (not Handset SIM Card):** Any non-data use via your Mobile Broadband SIM Card (eg voice calls, SMS/MMS and content) is charged in addition to your Vodafone Combo Cap or Vodafone Infinite Combo Product minimum monthly spend. The section below titled "Not payable from included value" specifies the additional rate at which you will be charged, if you use these services via your Mobile Broadband SIM Card.

- (x) Your “Included Mobile Broadband Data” and “Included Mobile Internet Data” are separate. When you access data services via your Mobile Broadband SIM Card, usage will be deducted from your Included Mobile Broadband Data. When you access data services via your Handset SIM Card, usage will be deducted from your Included Mobile Internet Data.

- (b) Minimum monthly spend for Unlimited BlackBerry® Email and Internet Browsing Pack Products excludes any additional mobile device payments (if applicable).
- (c) Cancellation will take effect from the end of the month on which you tell us that you want to stop receiving the Vodafone Unlimited BlackBerry® Email and Internet Browsing Pack Product. You will be billed until the end of that month.
- (d) Unlimited BlackBerry® Email and Internet browsing pack gives you unlimited BlackBerry data (BlackBerry® Internet Service (BIS) version only – excludes

BlackBerry® Enterprise Solution (BES) version) which includes BlackBerry® Email and Internet browsing, Facebook® and other applications, when accessed via the BlackBerry Access Point (APN) within Australia. Vodafone's Fair Use Policy applies. Additional charges apply for some services such as video streaming (e.g. YouTube) and single file downloads over 3 MB. Included voice value cannot be used for data. - (h) In the event that your eligible 12 or 24 month **voice** contract is cancelled, you will no longer be eligible for the Bundled Rate listed in the table above (you may also be liable for an Early Exit Fee for your voice contract – see your individual Cap or Plan for details).
